

## **PRIVACY POLICY for *thinc.* ‘The Hague Initiative for International Cooperation’**

Your privacy – *thinc.* consider the protection of your personal data and privacy particularly important. *thinc.* is fully committed to respect and protect your personal data. In this privacy policy, *thinc.* describe the collection, usage, storage and sharing practices of personal data.

The data controller for the processing is *thinc.* and the term 'websites' refers collectively to [www.thinc-israel.org](http://www.thinc-israel.org) as well as other websites under which *thinc.* operates. *thinc.*'s privacy policy also tells you about your rights and how the law protects you.

### **Your rights as someone whom *thinc.* has personal data about**

At any point while *thinc.* are in possession of or processing your personal data, you have the rights to:

- Access your data. You have the right to request a copy of the information that *thinc.* hold about you.
- Rectify your data. You have a right to correct data that *thinc.* hold about you that is inaccurate or incomplete.
- Erase your data. In certain circumstances you can ask for the data *thinc.* holds about you to be erased from our records. (If *thinc.* are legally obligated to keep the information or if it is impossible or disproportionate, *thinc.* will not delete it, but we will only keep it for as long as it is needed, and we have time limits on our data systems).
- Restrict the processing of data. Where certain conditions apply, you have a right to restrict the data processing.
- Portability of data. You have the right to have the data *thinc.* hold about you transferred to another organisation.
- Object to data. You have the right to object to certain types of processing such as direct marketing.
- Object to automated processing, including profiling of data. You also have the right not to have a computer make decisions about you directly.
- Judicial review. If *thinc.* refuses your request under rights of access, *thinc.* will provide you with the reason.
- Complaints. You have the right to complain.

*thinc.* is not responsible for websites not owned or controlled by us, e.g., social media platforms/services. *thinc.* encourages you to be aware and read the privacy policies of those websites as they may very easily be collecting, storing, using, and sharing your personal information.

### ***thinc.* rules for collecting data**

*thinc.* respects and value your privacy, and only ask for information needed in order for you to have a great online experience. Whenever *thinc.* collect personal related data, *thinc.* ensure that:

- *thinc.* asks for permission to collect the data.
- *thinc.* only uses the data for the agreed reason and for the time it is needed.
- *thinc.* will, as a minimum, meet the local data protection laws in the country where *thinc.* provides you with a service via our website or our applications.
- *thinc.* keeps data that we are legally required to have on record.
- *thinc.* explains why we need the data and how we will use it.
- *thinc.* checks and update privacy information on a regular basis.

- *thinc.* does not share data with anyone unless we have a legal or legitimate reason to, or we have permission from you.

## The information *thinc.* collects

*thinc.* collects your personal and anonymous information from you when you visit any of the sites on our *thinc-israel.org* domain. We also receive information via third parties when you visit our page on social media sites or channels (e.g., LinkedIn, Facebook, 'X', YouTube, Instagram, etc.).

The data that we may collect is as follows:

Registration data, which we use to help you set up an account (e.g., your email address, first name, last name, country,).

Donations or transactional data, which we use when you donate us or use online services (e.g., credit card number, name, e-mail)

## Why *thinc.* need to process personal data

Processing personal data refers to how *thinc.* collects, stores, uses, shares and delete the data *thinc.* receive from our subscribers and online users of *thinc.* website. When you share your personal information with us, *thinc.* will process your data according to this privacy policy.

*Thinc.* need to process personal data, so that:

- ✓ *thinc.* can give you the best online experience across our platforms.
- ✓ *thinc.* can tailor communication to your needs and wants.
- ✓ *thinc.* can ask for feedback on our services through questionnaires and surveys.
- ✓ *thinc.* can provide relevant marketing information about our activities and services
- ✓ *thinc.* can send any information asked for or answer questions.
- ✓ You can buy services from our online shop.
- ✓ You can register for any services *thinc.* provides.

Please read *thinc.*'s Cookie Policy for more information further down this document, including information about how to delete cookies places on your device and how to prevent them from being put there in the first place! Be mindful that if you do enable a prevent cookies functionality on your device, some of our services and functionalities on the site will no longer work.

## How long do *thinc.* keep your personal data?

In general, *thinc.* will keep your personal data if your account is active or if it is needed to provide you with a service. If you would like to cancel your account or for *thinc.* to delete your data, *thinc.* will only keep information that *thinc.* need for legal reasons, to resolve disputes or to enforce our agreements.

### Please note:

*thinc.* will store your personal data (email, phone, name etc.) if *thinc.* is in contact with you about our services, or until you instruct us to delete your data, or if there is a legal dispute with you, after which the data are being deleted – or anonymized.

## **Our cookie policy**

Cookies are small data files that your browser places on your computer or device. A cookie itself does not contain or collect information. However, when it is read by a server via a web browser, it can help a website deliver a more user-friendly service – for example, remembering login details and website settings/preferences.

Like most websites, our online website collect some information (e.g., IP addresses, browsers, internet service providers, browsing history, operating systems, date stamps, time stamps and clickstream data). This information will not be linked to any other information *thinc.* collect about you unless you have given your consent.

Both *thinc.* and our third-party tracking utility partners use browser storage, app storage, cookies, pixels, scripts, and tags to analyse trends, manage the site, track user movement through the site and collect demographic information about our overall user base. ## **Local legal requirements**

*thinc.* wants to make sure we, as a bare minimum, live up to the standards of data privacy and security outlined by the European General Data Protection Regulation (GDPR). This is something *thinc.* applies anywhere in the world where *thinc.* collects, stores, uses and/or share your personal data. If your local legal requirements surpass the rules outlined by GDPR, *thinc.* will adjust our practice to make sure your data is safely handled and stored with us, no matter where you are in the world.
